Annual Meeting and Awards Luncheon has record attendance



Lifetime Achievement Award winners Alex "Buzz" Bensinger and Ruth Sibley Bensinger

The Monroe County Historical Association's Annual Meeting and Awards Luncheon was held Sunday, February 28, 2010 in the Worthington Ballroom at the historic Shawnee Inn and Golf Resort. A record number of MCHA members, guests and friends participated in this year's event.

It may have been a cold February day, but 130 individuals attended and showed their support for the

Monroe County Historical Association and its mission to promote, protect, and preserve Monroe County's rich history.

The day began with an inspirational prayer offered by MCHA member Rev. William Ramsden who encouraged all to work together to safeguard Monroe County's history.

The Silent Auction continues to be a fun part of the day. Again this year, the Auction Committee worked hard to collect desirable items for our guests. Gift certificates from local restaurants and businesses, antiques, gift baskets, artwork, and jewelry filled the auction tables. All of the items received bids, and the Silent Auction brought in over \$2,000.00 for our organization. Thank you to Camille Breslauer, Auction Chair, Agnes Webb, Rose Ann Whitesel, and Anne Robertson for serving on the Auction Committee again this year.

After lunch, President David B. Thomas thanked the membership and the current Board of Directors for their continued support of MCHA and commended the MCHA staff for their continued hard work. Treasurer Patricia Sayler presented the 2009 financial summary and reported that the organization ended the year with a positive balance. Sayler offered the 2010 Budget Report which was accepted unanimously by the membership.

On behalf of the Nomination Committee, Clarence Murphy presented the following slate of nominees for the 2010 Board of Directors to serve their first term: Joan B. Groff and Ruth Sibley Bensinger. Two current Board members, Eugenia S. Eden and George Warden, were re-elected to serve a second term. Connie McCool retired from the MCHA Board, and Executive Director Amy Leiser and President Dave Thomas presented her with a framed print of the Stroud Mansion.



Following the brief business meeting, Kenn Anderson, Sr., dressed in costume, presented a fascinating talk titled, *Sullivan's March: Engineering Challenges on Land and Water.*

The audience was attentive and amazed as Kenn discussed the difficulties and logistics not only of moving troops, horses and livestock through the Pennsylvania wilderness, but also of the amount of food necessary to feed, multitude of mouths. There were over

Julie is a teacher of sixth and seventh grade students in the Pleasant Valley School District. The students become "history detectives" and use primary sources (maps, photographs, and artifacts) to research the early history of

Musings from the Mansion



Snow, snow, snow! Let it snow!



What fun I have been having! The snow shoes in the certainly encouraged me to get out and about. The funny thing is that the few pedestrians along Ninth and Main did seem to be αs pleased as I was about the current weather conditions. The pristine, white

blanket of snow conjured up images of skating on the farm pond, sledding down hills, and ending the day roasting chestnuts in the fireplace. I just wish I could share with these passersby how winters used to be!

Actually, winters were more than fun for many county residents in the past. For those in the higher elevations, harvesting ice from former log dams and natural lakes was a winter livelihood. With the ad-


vent of the railroad, major ice companies employed local workers to cut huge blocks of ice from these lakes and dams. Much of the ice was stored in wooden buildings longer that football fields and several stories high. Well into the warm weather, ice was shipped by rail to major cities for refrigeration.

Enough with work, let's get back to winter fun. You may not remember that local resorts in the late 1800's and early 1900's closed during the winter months. In the second decade of the 1900's, the railroads were being affected by the slow economy. George A. Cullen, agent for the Lackawanna Railroad, encouraged resorts to extend their season. We have to remember that most guests arrived by train and were transported from the local stations by carriages from the resorts. Buck Hill opened year-round in 1914 and was followed by Pocono Manor in 1916. These resorts realized that there was a potential for remaining open year-round if they had sufficient activities to engage their guests. The cold winters and an abundance of snow provided the essentials.

Tobogganing before World War I and skiing in the 1920's were favorites. Both resorts had ice hockey teams that played each other. The steep hills of the area were for the brave of heart who participated in ski jumping, leaping in the air for 200 feet and land-

ing at 60 miles per hour. Snowshoeing, ice boating, cross-country skiing, ice skating, skate sailing and, of course, sleigh rides all became a part of a resort's winter activities. It is interesting to note that a former winter activity is in vogue again. Pocono Manor was the first to introduce dog sledding back then. Alaskan style dog sleds were used for the sport. Buck Hill followed by accident when a guest never returned for 5 husky pups. Harry Drennan, then Winter Sports Director, raised the pups which grew to become Buck Hill's kennel of 40 sled dogs.

While many of these sports may sound exciting to the more adventurous; I feel that snow-shoeing is just right for me. But just now, it's time for a snack of a few chosen nuts in my special corner of the Mansion.



In Memoriam

The Monroe County Historical Association honors with sympathy the passing of two outstanding Board members and friends to our organization.

Dr. Otto R. Weber, M.D., moved to Stroudsburg in 1962 serving as an OB-GYN. Following his retirement, Dr. Weber went back to school and received his master's degree in history from ESU. He served as a member of the Board of Directors from 2000 - 2004.

Mrs. Dee G. Christine was an avid participant in the community. She respectfully earned her reputation as one of Monroe County's most prominent volunteers, devoting her time and talents to many organizations, including serving as President of the MCHA Board of Directors from 1976-1978.

Both of these individuals believed in the importance of preserving, protecting and promoting Monroe County's history. Each has made a tremendous impact on the community and will be greatly missed.




18th Annual Victorian Tea and Luncheon Update
